# ORDER DESIGNATING PREHEARING OFFICER AND SETTING PREHEARING CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

- 1. On July 3, 2018, TGT Petroleum Corporation ("Applicant") filed an Application for an exception to the 10-year time limitation of K.A.R. 82-3-111 for its Wheeler F#1 well located in Kiowa County, Kansas.<sup>1</sup>
- 2. On July 20, 2018, Voskuhl Staab Family Farms LLC filed a letter protesting application.<sup>2</sup>
  - 3. On July 24, 2018, Morning Star Farms, GP filed a letter protesting application.<sup>3</sup>
- 4. On July 25, 2018, Jonathan A. Schlatter entered his appearance on behalf of the Applicant.<sup>4</sup>

5. The Commission finds that a Prehearing Officer should be designated in this proceeding to address matters pursuant to K.S.A. 77-516-517.<sup>5</sup> The Commission also finds that a prehearing conference should be scheduled in this matter.

#### THEREFORE, THE COMMISSION ORDERS:

- A. - B. A Prehearing Conference is scheduled for **Tuesday**, **August 21**, **2018**, **at 8:30 a.m.** by telephone. The conference call information is: telephone number (866) 620-7326, Conference Code PIN: 7632914771#.
- C. At the Prehearing Conference, parties shall be prepared to discuss deadlines for filing testimony and briefs, discovery procedures, scheduling of a hearing with the Commission, and any other issues that will promote the orderly and prompt resolution of this proceeding.
- D. At the Prehearing Conference, without further notice, this proceeding may be converted into a conference hearing or a summary proceeding for disposition of this matter as provided by the Kansas Administrative Procedure Act (KAPA). Any party that fails to attend or participate in the Prehearing Conference, hearing, or other stage of this proceeding may be held in default under the KAPA.<sup>6</sup>
  - E. A corporation shall appear before the Commission by a Kansas licensed attorney.<sup>7</sup>
