ORDER SUSPENDING INTRASTATE MOTOR CARRIER OPERATIONS

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

I. JURISDICTION AND BACKGROUND

- 1. Pursuant to K.S.A. 66-1,108b, 66-1,111, 66-1,112, and 66-1,114b, the Commission is given full power, authority and jurisdiction to supervise and control motor carriers, as defined in 40 C.F.R. 390.5 as adopted by K.A.R. 82-4-3f, doing business or procuring business in Kansas, and is empowered to do all things necessary and convenient for the exercise of such power, authority, and jurisdiction.
- 2. Pursuant to K.S.A. 66-1,129a, 66-1,130, and 66-1,142b, the Commission may suspend operations, revoke, or amend certificates, and initiate sanctions or fines against every motor carrier and every person who violates any provision of Kansas law in

regard to the regulation of such motor carriers and persons, or who fails to obey any order, decision, or regulation of the Commission.

3. Pursuant to K.S.A. 66-1,129(a)(7), the Commission has adopted motor carrier transportation regulations (K.A.R. 82-4-3f) consistent with the federal motor carrier safety assistance program and other federal requirements concerning transportation of hazardous waste.

II. FINDINGS OF FACTS

- 4. Vegas Trucking LLC of Oberlin, Kansas (Carrier) is a motor carrier as defined in 49 C.F.R. 390.5 as adopted in K.A.R. 82-4-3f, that operates commercial motor vehicle(s) in intrastate commerce.
 - 5. Carrier operates under USDOT Number 3458956.
- 7. Transportation Staff (Staff) Special Investigators Penny Fryback and Erica Pargas are conducting an investigation of the carrier. During the investigation, Staff discovered a number of major violations, including:
 - a. Carrier obtained its USDOT number of July 24, 2020 using a fraudulent address, utilizing a Mexican issued commercial driver's license.
 - b. Carrier has been found operating in interstate, but is self-declared to be an intrastate carrier on its Motor Carrier Identification Report dated November 3, 2021, which is attached hereto as Attachment "A." Carrier does not have federal interstate authority to operate, nor does it have intrastate authority to operate from the Kansas Corporation Commission (Commission) despite also operating point to point in Kansas.

- c. Carrier has failed to pay International Fuel Tax Agreement (IFTA) fees
 and has no International Registration Plan (IRP) plates, as required.

 Carrier has been found operating commercially using non-commercial
 plates issued by Nebraska.
- d. Carrier has several recent roadside inspections conducted by the KHP prior to and during this investigation. In five recent roadside inspections the Carrier was found using drivers that did not possess a valid U.S. commercial driver's license (CDL). The three most recent inspections noted:
 - i. On July 14, 2022, the Kansas Highway Patrol (KHP) conducted a roadside inspection documented in Driver/Vehicle Examination Report KSHP04150725, which is attached hereto as Attachment "B." At the time of this inspection, Tomas Vega-Casillas, owner of Carrier, was found operating without a valid U.S. CDL. The inspector noted "Does not possess a CDL issue[d] by state of domicile. Driver stated has lived in Kansas for a year." K.S.A. 8-2134 states: "No person who has been a resident of this state for 30 days shall drive a commercial motor vehicle under the authority of a commercial driver's license issued by another jurisdiction."
 - ii. On August 15, 2022, the KHP conducted a roadside inspection documented in Driver/Vehicle Examination Report KSHP03794528, which is attached hereto as Attachment "C." At

- the time of this inspection, Tomas Vega-Casillas, owner of Carrier, was again found operating without a valid U.S. CDL.
- iii. On September 7, 2022, the KHP conducted a roadside inspection documented in Driver/Vehicle Examination Report KSHP03794528, which is attached hereto as Attachment "D" At this time of this inspection, Hector Vega Bencomo (Tomas Vega's son) was found operating without a valid CDL. Mr. Bencomo provided KHP Trooper Bradley a Mexican CDL that was not valid (expired 12/2021).
- e. The inspections evidence of a number of maintenance violations that were not been repaired or corrected before being used in operation again.
- f. Carrier failed to provide proof of insurance for the units being operated during the roadside inspection on September 7, 2022. At this time it is unknown if Mr. Vega possesses active, required insurance.
- 6. Staff recommended the Commission suspend Carrier's intrastate motor carrier operations until it complies with the applicable motor carrier safety rules and regulations and submits a Corrective Action Plan that meets Staff's approval. Staff's findings and recommendation are evidenced by an e-mail from Special Investigator Erica Pargas, sent September 8, 2022. A copy of the e-mail is attached hereto as Attachment "E" and is hereby incorporated by reference
- 7. On September 12, 2022, Commission Staff filed a Motion to Suspend Intrastate Motor Carrier Operations, requesting that such an action be taken because Carrier's continued operations pose a danger to the motoring public. Staff requested

Carrier's intrastate motor carrier operations remain suspended until it complies with the applicable motor carrier safety rules and regulations and submits a Corrective Action Plan that meets Staff's approval.

III. CONCLUSIONS OF LAW

- 8. The Commission finds it has jurisdiction over Carrier as the Carrier is a motor carrier as defined in 49 C.F.R. 390.5 as adopted by K.A.R. 82-4-3f.
- 9. The Commission finds Carrier is operating in violation of the applicable motor carrier safety rules and regulations.
- 10. The Commission finds Carrier's noncompliance with the applicable motor carrier safety rules and regulations poses a potential immediate threat to the safety and welfare of the public of the state of Kansas. Further, Carrier's noncompliance is intentional and therefore this Commission orders the Carrier to suspend all intrastate motor carrier operations other than such motor carrier operations excepted from the Commission's regulation under K.S.A. 66-1,129, until such time as the carrier takes the necessary steps to become compliant.

THE COMMISSION THEREFORE ORDERS THAT:

A. Vegas Trucking LLC of Oberlin, Kansas is to be immediately suspended from all intrastate commercial motor carrier operations other than such motor carrier operations excepted from the Commission's regulation under K.S.A. 66-1,129, until such time as Carrier submits a Corrective Action Plan that meets Staff's approval and comes into compliance with the applicable motor carrier safety rules and regulations. This Suspension of Intrastate Motor Carrier Operations Order may also attach and apply to the operations of successor entities, including any motor carrier entity or entities established

or used to avoid the consequences of any Order to cease operations or suspending

operating authority.

B. Pursuant to K.S.A. 77-537 and K.S.A. 77-542, any party may request

a hearing on the above issues by submitting a written request, setting forth the

specific grounds upon which relief is sought, to the Commission's Secretary, at 1500

S.W. Arrowhead Road Topeka, Kansas 66604 within fifteen (15) days from the date

of service of this Order. Failure to timely request a hearing will result in a waiver of

Carrier's right to a hearing, and this Order will become a Final Order against Carrier,

suspending Carrier's motor carrier operations.

C. If a request for hearing is filed, attorneys for all parties shall enter their

appearances in Commission proceedings by giving their names and addresses for the

record.

D. Failure to comply with the provisions of this Order may result in further

sanctions to include, but not limited to, the assessment of civil penalties and/or the

impoundment of commercial motor vehicles found operating in violation of this Order

and any other remedies available to the Commission by law, without further notice.

E. The Commission retains jurisdiction over the subject matter and the

parties for the purpose of entering such further orders, as necessary.

Good Afternoon,

We would like to request an Emergency Suspension on carrier: Vegas Trucking LLC (USDOT #3458956) based on the following issues that have been discovered which pose a danger to the traveling public:

- 1. Vegas Trucking LLC obtained their USDOT number on 7/24/2020 using a fraudulent address, and with a Mexico CDL.
- 2. Vegas Trucking LLC is an Intrastate carrier that has been operating in Interstate Commerce without an interstate USDOT number and has been operating point to point in Kansas without KCC Authority.
- 3. Vegas Trucking LLC has failed to pay IFTA, and has no IRP. Some of the vehicles are being operated with regular County Nebraska Tags.
- 4. Vegas Trucking LLC has been cited on five (5) different occasions for using drivers without a valid CDL. Specifically, On 7/14/22, Driver and Owner of Vegas Trucking LLC, Tomas Vega was put OOS for operating on a Mexico CDL while a resident of Kansas. Tomas Vega was put OOS again for the same violation on 8/15/2022. On 9/7/2022, Hector Vega Bencomo (Tomas Vega's son) was placed OOS for operating without a Valid CDL. Hector Vega Bencomo provided KHP Trooper Bradley with a Mexico CDL that was not valid and a Tourist Visa that does not allow tourists to be employed while in the US.
- 5. Vegas Trucking LLC continues to operate units that have been previously placed OOS. On 7/14/2022 the Truck Tractor and Trailer being operated were placed OOS for numerous violations. On 8/15/2022, the same vehicle was placed OOS and the company was cited for failure to correct defects previously noted on a roadside inspection.
- 6. Vegas Trucking LLC failed to provide proof of Insurance for the units being operated on 9/7/2022. At this time, it is unknown if Tomas Vega currently has active insurance.
