APPLICATION OF NEX-TECH, LLC FOR AN ORDER CONFIRMING RELINQUISHMENTOF ITS ELIGIBLE TELECOMMUNICATIONS CARRIER DESIGNATION AND NOTICE OF INTENT TO CEASE PARTICIPATION IN THE KANSAS LIFELINE SERVICES PROGRAM

COMES NOW Nex-Tech, LLC ("Nex-Tech"), pursuant to 47 U.S.C. § 214(e)(4), 47 C.F.R. § 54.205, K.S.A. 2015 Supp. 66-2006(d), K.S.A. 2015 Supp. 66-2008, K.S.A. 2015 Supp. 2009, K.A.R. 82-1-218 and K.A.R. 2015 Supp. 82-1-219, and respectfully requests an order confirming:

- (i) relinquishment of its Eligible Telecommunications Carrier ("ETC") designation for all of its local exchange service areas in Kansas specified herein, effective
 May 31, 2019; and
- (ii) its notice of intent to cease participation in the Kansas Lifeline Services Program ("KLSP"), effective May 31, 2019.

This application and notice provides both the notice required by 47 U.S.C. § 214(e)(4) to relinquish an ETC designation and the ninety-day written notification of Nex-Tech's intent to cease participation in the KLSP required by K.S.A 2015 Supp. 66-2006(d). In support of its application and notice Nex-Tech states as follows:

BACKGROUND

- 1. Nex-Tech is a Kansas Limited Liability Company and telecommunications carrier providing competitive local exchange service pursuant to certificate of convenience and authority issued by this Commission. Nex-Tech was designated an ETC in the Southwestern Bell Telephone Company d/b/a AT&T Kansas ("AT&T") exchanges by Commission Order dated October 18, 2004 in KCC Docket 05-NTHT-140-ETC and Commission Order dated June 16, 2006 in KCC Docket 06-NTHT-1022-ETC. Nex-Tech was additionally designated an ETC in the Sprint/United ("CenturyLink") exchanges by Commission Order dated June 8, 2004 in KCC Docket 04-NTHT-498-ETC.
- 2. Nex-Tech desires to relinquish its ETC designation in all exchanges in which it has been designated. Those exchanges are contained in Exhibits A and B.
- Nex-Tech's relinquishment request is prompted by changes in both federal and state high
 cost support. Additionally, the ETC designation creates increased regulatory obligations. Nex Tech
 believes maintaining its ETC designation is not justified.
- 4. Nex-Tech's relinquishment of ETC status will not affect the ability of other ETCs to participate in the federal universal service program, including Lifeline.
- Nex-Tech's relinquishment of ETC status will not adversely affect any consumers as
 Nex-Tech will continue to offer services to customers in the relinquished areas.

LEGAL STANDARD FOR RELINQUISHING ETC STATUS

6. The standard for relinquishing an ETC designation is set forth in 47 U.S.C. § 214(e)(4) which states in part:

A State commission ...shall permit an eligible telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier. An eligible telecommunications carrier that seeks to relinquish its eligible telecommunication carrier designation for an area served by more

than one eligible telecommunications carrier shall give advance notice to the State commission ... of such relinquishment. Prior to permitting a telecommunications carrier designated as an eligible telecommunications carrier to cease providing universal service in an area served by more than one eligible telecommunications carrier, the State Commission ... shall require the remaining eligible telecommunications carrier or carriers to ensure that all customers served by the relinquishing carrier will continue to be served, and shall require sufficient notice to permit the purchase or construction of adequate facilities by any remaining eligible telecommunications carrier. The State commission...shall establish a time, not to exceed one year after the State commission...approves such relinquishment under this paragraph, within which such purchase or construction shall be completed.

- 7. Nex-Tech's Application meets the requirements of Section 214(e)(4) for relinquishment of its ETC designation. The relinquished areas are served by one or more remaining Eligible Telecommunications Carriers.
- 8. In the AT&T exchanges listed in Exhibit A, the Commission Staff has identified the remaining ETCs available to consumers in Staff's Exhibit 2 in its Second Report and Recommendation dated May 3, 2017 in Docket 17-SWBT-158-MIS (attached as Exhibit C). AT&T is committed to continue to provide voice service in all of its relinquished areas. In those areas AT&T is not relinquishing, AT&T remains an ETC.
- 9. CenturyLink remains an ETC in the areas identified in attached Exhibit B of the requested relinquishment areas.

NOTICE OF INTENT TO CEASE PARTICIPATION IN THE KLSP

- 10. Under K.S.A. 2015 66-2006(d) "Telecommunications carriers and electing carriers may cease participation in the KLSP at any time upon provision of 90-days prior written notification to the commission."
- 11. Pursuant to and in accordance with K.S.A. 66-2006(d), Nex-Tech hereby provides the Commission written notification of its intention to cease participation in the KLSP as of May 31, 2019. This is the same date as the requested relinquishment effective date, which is important to coordinate with the notice messages Nex-Tech will provide to affected customers.

CUSTOMER NOTIFICATION OF TERMINATION OF KLSP DISCOUNT AND ETC RELINQUISHMENT

- 12. To ensure that each of its affected Lifeline customers receives ample notice of the need to select another ETC in order to continue receiving the Lifeline and KLSP discount, Nex-Tech will provide two separate notices to customers in the area where Nex-Tech is relinquishing its ETC designation.
- separate letter via U.S. Mail to each of its affected Lifeline customers in the relinquishment area explaining that Nex-Tech will no longer offer a Lifeline or KLSP discount. Nex-Tech will also send affected customers a similar second notice letter and a bill message at least 15 days prior to the effective date. All notices will inform each affected customer that a Lifeline discount and/or KLSP discount may be obtained from the remaining ETCs in the area and will provide a link to lifelinesupport.org through which a customer may obtain carrier-specific contact information. All affected Lifeline customers will continue to receive service from Nex-Tech, although the KLSP discount will be removed as of May 31, 2019. Exhibit D is a sample copy of the language that will be used in the two separate sets of letters and bill messages that Nex-Tech intends to deliver to each of its affected customers.
- 14. To avoid customer confusion and assist with a smooth transition process, as of January 1, 2019, Nex-Tech will discontinue enrolling customers in the KLSP and also discontinue enrolling customers in the relinquishment area of the federal Lifeline program.

RELIEF REQUESTED

WHEREFORE Nex-Tech respectfully requests the Commission grant its application and issue an order confirming relinquishment of its ETC designation in all previously granted Exchanges effective

May 31, 2019 and confirming the foregoing notice that it will cease participation in the KLSP effective on May 31, 2019.
