#### **BACKGROUND:**

On December 30, 2010, MCC Missouri, LLC, (MCC), d/b/a Mediacom, filed an initial application for state-issued Video Service Authorization, as provided by K.S.A. 12-2023 and K.A.R. 85-15-1.

In accordance with K.S.A. 12-2023(a) and K.A.R. 82-15-1(f)(2), Commission action in this matter is required not later than **Friday**, **January 28**, **2011**.

#### **ANALYSIS:**

MCC has identified its principal place of business as 100 Crystal Run Road, Middletown, New York, 10941. The filing identified its principal officers as: Mr. Rocco Cossisso, Chief Executive Officer; Mr. Mark Stephan, Executive Vice President; and Mr. John Pascarelli, Chief Operating Officer. Mr. Thomas Larsen, Vice President of Legal and Public Affairs, is designated as the ongoing regulatory contact and point of contact for consumer complaint matters.

The Applicant is organized under the laws of Missouri, registered with the Kansas Secretary of State's office as a Foreign Limited Liability entity, and is currently (a/o 1-5-2011) 'Active and in Good Standing' with that office.

Specifically, the Applicant is requesting state-issued authority in the cities of Eureka, Galena, Scranton, Baldwin, and Oswego and has provided the following legal descriptions:

Eureka, Township 25S, Range 10E, Sections 2, 3, 4, 33, 34 and 35.

Galena, Township 34S, Range 25E, Sections 11, 13, 14, 15, 23, 24, 25 and 26.

Scranton, Township 15S, Range 15E, Sections 3 and 4, Township 14S, Range 15E, Section 34.

Baldwin, Township 14S, Range 19E, Sections 27, 28, 33, 34, Township 15S, Range 19E, Sections 2, 3 and 4.

Oswego, Township 33S, Range 21E, Sections 15, 16, 17, 20, 21 and 22.

The Applicant is currently providing service in the described service areas under local agreements and states that they currently serve 100% of the service area footprint.

For ease of future reference, Staff has assigned the proposed service areas the following identifiers<sup>1</sup>:

The Applicant has provided a high level sketch and a general description of the architecture and components used in providing its video service.

The Applicant has agreed to comply with all applicable federal and state statutes and regulations and agrees to comply with all lawful and applicable municipal regulations regarding the use and occupation of public rights-of-way in the delivery of video services, including the police powers of the municipalities in which the service is delivered. (Initial Application item #5).

The Applicant has affirmed that it will not deny its services to potential customers based on the average population income. (Last item of Initial Application.)
