## APPLICATION FOR A CERTIFICATE OF PUBLIC CONVENIENCE AND AUTHORITY TO TRANSACT THE BUSINESS OF AN ELECTRIC PUBLIC UTILITY

COMES NOW Westar Energy, Inc. (Westar Energy), and in support of its Application for a Certificate of Public Convenience and Authority, states:

Westar Energy is a Kansas corporation authorized by the Commission pursuant to K.S.A. 66-104 to conduct the business of a public utility, and as such holds a Certificate of Convenience and Authority from this Commission to engage in the business of an electric public utility in the State of Kansas, thereby promoting the public convenience.

Westar Energy seeks to serve, subject to the Commission's approval, in
Leavenworth Jefferson Electric Cooperative (Leavenworth Jefferson EC) certified territory described below:

## LEAVENWORTH COUNTY, KANSAS

A tract of land described as the Northeast ¼ of the Northeast ¼ of the Southwest ¼ of Section 16, Township 9 South, Range 22 East, in Leavenworth County, Kansas, as detailed on the map marked Exhibit A and attached hereto.

 Westar Energy and Leavenworth Jefferson EC are working together to correct territory issues. Westar Energy is currently serving the tract of land described in Paragraph 1 although it is in Leavenworth Jefferson EC's certified territory.

- Leavenworth Jefferson EC has agreed to cease serving the tract of land described in Paragraph 1, subject to the Commission's approval, to correct the existing territory discrepancies.
- 4. Westar Energy understands that Leavenworth Jefferson EC has filed, or will soon file, an application with the Commission to cease serving its electric service in the territory described in paragraph 1.
