**JOINT MOTION FOR PROCEDURAL SCHEDULE**

Sunflower Electric Power Corporation (“Sunflower”), and Wheatland Electric Cooperative, Inc. (“Wheatland”) and together as “Joint Applicants,” the Staff of the State Corporation Commission of the State of Kansas (“Staff” and “Commission,” respectively), KPP Energy (“KPP”), and the Kansas Electric Power Cooperative, Inc. (“KEPCo”) (collectively referred to as the “Joint Movants”) hereby move the Commission for an Order establishing a procedural schedule in the above-captioned matter. In support of their motion, Joint Movants state the following:

1. On February 5, 2025, the Joint Applicants filed their Joint Application seeking approval an updated Local Access Charge (“LAC”) and a 34.5kV formula-based rate associated with Wheatland’s 34.5kV sub-transmission system.
2. On February 10, 2025, KPP filed a Petition to Intervene, and was granted intervention on February 19, 2025.
3. On February 14, 2025, KEPCo filed a Petition to Intervene, and was granted intervention on February 20, 2025.
4. In informal discussions between parties, the Joint Movants indicated their willingness to collaborate on a schedule.

5. To the best of Joint Movants' abilities at this time, the proposed schedule takes into consideration the timing of certain holidays occurring within the allotted proceeding period, as well as individual scheduling concerns of all parties. The proposed procedural schedule agreed to by Joint Movants is as follows:
