ORDER REINSTATING MOTOR CARRIER OPERATING AUTHORITY

)

The above-captioned matter comes on for consideration and determination by the State Corporation Commission of the State of Kansas ("Commission") for consideration and determination upon its own motion. Having examined its files and records, the Commission, finds and concludes:

I. **Legal Standards**

1. Pursuant to K.S.A. 66-1,108b, 66-1,111, 66-1,112 and 66-1,114b, and amendments thereto, the Commission is given full power, authority and jurisdiction to supervise and control motor carriers, as defined in K.A.R. 82-4-3f, doing business or procuring business in Kansas, and is empowered to do all things necessary and convenient for the exercise of such power, authority, and jurisdiction.

2. Pursuant to K.S.A. 66-1,129a, 66-1,130, and 66-1,142b, and amendments thereto, the Commission may suspend operations, revoke, or amend certificates, and initiate sanctions or fines against every motor carrier and every person who violates any provision of Kansas law in

regard to the regulation of such motor carriers and persons, or who fails to obey any order, decision, or regulation of the Commission.

3. Pursuant to K.S.A. 66-1,129(a)(7), the Commission has adopted motor carrier transportation regulations (K.A.R. 82-4-3f) consistent with the federal motor carrier safety assistance program and other federal requirements concerning transportation of hazardous waste.

II. Analysis

4. 145RUNS LLC is a motor carrier as defined in 49 C.F.R. 390.5 as adopted by K.A.R. 82-4-3f that operates commercial motor vehicle(s) in both intrastate and interstate commerce in a manner that requires authority.

5. 145RUNS LLC is registered as a motor carrier with the U.S. Department of Transportation (USDOT) and operates under USDOT Number 3817889.

6. The Commission received notice from the U.S. Department of Transportation, Federal Motor Carrier Safety Administration that 145RUNS LLC's New Entrant Registration had been revoked effective December 27, 2024, for failure to comply with safety requirements.

7. Pursuant to the above authority, on January 7, 2025, the Commission entered an Emergency Suspension of Operating Authority Order on 145RUNS LLC in the above-referenced docket, until such time that Staff recommended reinstatement.

8. On January 29, 2025, the Staff of the Transportation Division of the Kansas Corporation Commission (Staff) received notice from the U.S. Department of Transportation, Federal Motor Carrier Safety Administration, that 145RUNS LLC has submitted evidence of compliance with safety requirements as required in 49 C.F.R. 385.329. As a result, the carrier's reapplication for New Entrant registration under USDOT No. 3817889 has been approved and the

carrier's authority to operate in interstate operations has been reinstated. See attached FMCSA reinstatement documentation, a copy of which is attached hereto as Attachment "A" and is hereby incorporated by reference.

9. Carrier further submitted evidence of attendance at a Kansas Corporation Commission-sponsored safety seminar. A representative of Carrier attended on March 21, 2024, which Staff deemed to be compliant. See attached KTRAN screenshot, a copy of which is attached hereto as Attachment "B" and is hereby incorporated by reference.

10. The Commission finds it has jurisdiction over 145RUNS LLC because it is a motor carrier as defined in 49 C.F.R. 390.5 as adopted by K.A.R. 82-4-3f.

The Commission finds that by attending a Commission-sponsored safety seminar,
145RUNS LLC has met the requirements of the January 7, 2025, Emergency Suspension of
Operating Authority Order.

12. Based on the Federal Motor Carrier Safety Administration's reinstatement, the Commission concludes it should reinstate 145RUNS LLC's motor carrier operations in Kansas.

THE COMMISSION THEREFORE ORDERS THAT:

A. 145RUNS LLC's intrastate motor carrier operations in Kansas are hereby reinstated.

According to the Federal Motor Carriers Safety Administration's records, thirty days have elapsed since 145RUNS LLC's US DOT New Entrant registration was revoked on December 27, 2024, based on a failure to submit to a required safety audit. Our records also indicate that 145RUNS LLC has reapplied in accordance with 49 CFR section 385.329. 145RUNS LLC's reapplication for USDOT New Entrant registration has been approved. However, because a safety audit has not yet been conducted, 145RUNS LLC should contact your local State Motor Carrier Safety Assistance Program (MCSAP) office 785-296-7818 as soon as possible to schedule a safety audit. In accordance with section 49 C.F.R. § 385.337, failure to permit a safety audit to be performed may result in the revocation of 145RUNS LLC's USDOT New Entrant registration and 145RUNS LLC's interstate operation being placed out of service. Additionally, the refusal to submit to a safety audit may also subject a new entrant motor carrier to the penalty provisions in 49 U.S.C. 521(b) (2) (A), as

145RUNS LLC's 18-month new entrant safety monitoring period restarts as of January 29, 2025. FMCSA will continue to monitor and evaluate 145RUNS LLC's safety management practices and on-road performance to ensure 145RUNS LLC has basic safety management controls that are operating effectively and is complying with Federal requirements including the Federal Motor Carrier Safety Regulations (FMCSRs) and applicable Federal Hazardous Materials Regulations (HMRs). Failure to comply with applicable requirements may result in the revocation of 145RUNS LLC's USDOT New Entrant or permanent registration.
