**COMPLAINANT RESPONSE TO NOTICE OF FILING OF STAFF’S REPORT AND  
RECOMMENDATION DATED AUGUST 24, 2020**

On August 24, the Kansas Corporate Commission filed a “Notice of Filing of Staff’s Report and Recommendation” in the above case. In the report, Staff references several questions that were sent to KCP&L/Evergy without the Complainant being notified. This constitutes Ex-parte communication between KCC and KCP&L. Complainant asks that Staff provide all correspondence between Staff and KCP&L regarding this Complaint and that staff provide transcripts of any telephone conversations that took place between anyone at KCCC and KCP&L to the Complainant within 30 days.

**Introduction**

In Staff’s report of August 24, 2020, Staff references questions 1, 4, 3, 8 and 29 Footnotes. This information, and possibly other information, was gathered without the knowledge of the Complainant. This was done Ex-parte and Complainant should have been notified of all communication that occurred.

1. Complainant asks that KCCC Staff provide all correspondence between KCC Staff and KCP&L regarding this Complaint and that Staff provide transcripts of

any telephone conversations that took place between anyone at KCCC and KCP&L to the Complainant within 30 days.
