JOINT MOTION FOR PROCEDURAL SCHEDULE AND WAIVER OF STATUTORY TIMELINE

Sunflower Electric Power Corporation ("Sunflower"), and Prairie Land Electric Cooperative, Inc. ("Prairie Land") and together as "Joint Applicants," the Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission," respectively), KPP Energy ("KPP"), Kansas Municipal Energy Agency ("KMEA"), and the Kansas Electric Power Cooperative, Inc. ("KEPCo") (collectively referred to as the "Joint Movants") hereby move the Commission for an Order establishing a procedural schedule in the above-captioned matter. In support of their motion, Joint Movants state the following:

- 1. On August 11, 2025, the Joint Applicants filed their Joint Application seeking approval of Continuation of Prairie Land's 34.5kV formula-based rate.
- 2. On August 18, 2025, KEPCo filed a Petition to Intervene, and was granted intervention.
- 3. On August 20, 2025, KPP filed a Petition to Intervene, and was granted intervention.
- 4. On August 20, 2025 KMEA filed a Petition to Intervene, and was granted intervention.

- 5. On August 28, the Commission filed a Suspension Order which suspended the effective date of this docket for 240 days until April 8, 2026.
- 6. In informal discussions between parties, the Joint Movants indicated their willingness to collaborate on a schedule.
- 7. To the best of Joint Movants' abilities at this time, the proposed schedule takes into consideration the timing of certain holidays occurring within the allotted proceeding period, as well as individual scheduling concerns of all parties. The proposed procedural schedule agreed to by Joint Movants is as follows:

- 8. The Joint Applicants hereby agree to waive the 240-day statutory requirement for this docket as set forth in K.S.A. 66-117(c), and extend the commission order date to April 24, 2026, to allow the Commission ample time to draft its final order.
- 9. Additionally, the Joint Movants have agreed to allow the Joint Applicants an extended deadline to file the 2026 Annual Update (in accordance FBR protocols as approved by the Commission in this docket) past May 1, 2026, if so required, but not later than June 1, 2026.
- 10. In the event that the Joint Applicants file the 2026 Annual Update after May 1, 2026, the additional deadlines as set forth in the protocols shall be prorated in accordance with the filing date, which shall apply to the 2026 Annual Update only.

WHEREFORE, Joint Movants respectfully request the Commission issue an order granting this Joint Motion and approving the procedural schedule set forth above.
