**ORDER GRANTING STAFF’S MOTION FOR PROCEDURAL SCHEDULE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

1. On March 31, 2022, pursuant to K.S.A. 66-1,240 *et seq.*, Kansas Gas Service, a Division of ONE Gas, Inc. (KGS) filed an Application for Financing Order for permission to issue Securitized Utility Tariff Bonds to finance the Qualified Extraordinary Costs incurred due to Winter Storm Uri.<sup>1</sup>

2. On April 18, 2022, Commission Staff (Staff) filed a Motion for Procedural Schedule, suggesting the following schedule:
