BACKGROUND:

On June 2, 2008, Wildflower Telecommunications, LLC applied for Certification to provide Interexchange Carrier Services and Operator Services Within the State of Kansas.

ANALYSIS:

Wildflower Telecommunications, LLC is a Kansas corporation and was properly registered with the Kansas Secretary of State's office on February 10, 2006. They are currently "active and in good standing" with the Secretary's office.
