## **STATUS UPDATE GRANTING 30-DAY EXTENSION**

On August 20, 2019, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket.<sup>1</sup> On June 8, 2023, Commission Staff filed a Motion to Approve Amended Compliance Agreement.<sup>2</sup> On June 20, 2023, the Commission issued an Order Granting Motion to Approve Amended Compliance Agreement.<sup>3</sup> The Amended Agreement provides that Operator may request an extension of time to achieve compliance for up to 30 days from an applicable deadline established under the Agreement upon good cause shown.<sup>4</sup> Staff will grant or deny such request.<sup>5</sup>

On January 25, 2024, Operator requested an extension of its January 31, 2024, deadline. The District #2 Supervisor believes Operator's reasons for the request demonstrated good cause for an extension. Commission Staff grants Operator's extension request. Under the Agreement, Operator's January 31, 2024, deadline is extended to February 29, 2024.
