**MOTION TO CLOSE DOCKET**

The Staff of the State Corporation Commission of the State of Kansas (“Staff” and “Commission,” respectively) files this *Motion to Close Docket*. In support of its Motion, Staff states as follows:

1. On May 30 2017, Operator submitted an application for a license.
2. On June 2, 2017, Commission Staff denied Operator’s license application because of Operator’s association with Westside Energy L.C., License #31235, which was not in good standing with the Commission.
3. On June 14, 2017, Operator timely requested a hearing.
4. On July 13, 2017, the Commission issued an Order Designating Prehearing Officer and Setting Prehearing Conference.
5. On December 5, 2017, Operator filed a motion to join a necessary party, to which no party responded, and which the Commission has not yet ruled upon.
6. On January 31, 2018, the prehearing officer stayed the procedural schedule.
7. Subsequent to the procedural schedule being stayed, Westside Energy’s compliance issue was resolved. Specifically, the four unplugged well records on the license were transferred to Poverty Knob Production, LLC, License #35117.
8. Thus, all issues that had caused Operator’s license renewal application to be denied have been resolved. Accordingly, Staff has now processed Operator’s license application.

WHEREFORE, as no issues remain to be resolved, Staff respectfully moves the Commission for this docket to be closed.



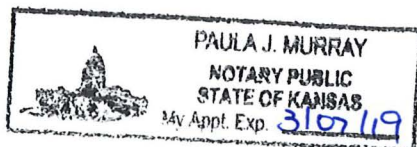
