## AMENDMENT TO PETITION FOR LIMITED DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

#### I. INTRODUCTION

- 1. Virgin Mobile USA, L.P. ("Virgin Mobile" or the "Company"), pursuant to section 214(e)(2) of the Communications Act of 1934, as amended, 47 U.S.C. § 214(e)(2), hereby amends its pending petition for limited designation as an eligible telecommunications carrier ("ETC") in the State of Kansas ("Petition"), which it filed with the Kansas Corporation Commission ("Commission") on April 12, 2010. As discussed below, Virgin Mobile hereby amends its Petition by substituting the undersigned counsel for the counsel previously appearing in this proceeding.
- 2. Virgin Mobile submits that appearance of Kansas-admitted counsel on behalf of the Company should remove any remaining impediment to the Commission's prompt approval of the pending Petition. Rapid grant of the request would advance the public interest because it would enable the Company to commence much needed Lifeline services to lower-income Kansas residents as soon as possible.

### II. APPEARANCE OF COUNSEL

3. Virgin Mobile amends its pending Petition by substituting undersigned counsel for the counsel previously appearing in this proceeding. As counsel of record, the undersigned hereby adopts and certifies the Company's previous submissions in this proceeding.

### III. CONCLUSION

4. WHEREFORE, Virgin Mobile respectfully requests that the Commission approve the appearance of the undersigned counsel and promptly designate Virgin Mobile as an ETC in the State of Kansas solely for purposes of participating in the Lifeline program.
