ORDER DESIGNATING PREHEARING OFFICER AND SETTING PREHEARING CONFERENCE

1. On February 12, 2015, the Commission issued the Penalty Order in this docket, finding one violation of K.A.R. 82-3-111 and assessing a \$100 penalty. No appeal was filed.

2. On June 2, 2015, the Commission issued a second Penalty Order in this docket

due to noncompliance at the Hoffman #1-25 and the existence of four additional unplugged wells

on the operator's license. The second Penalty Order assessed a \$10,000 penalty and directed

Staff to plug the wells if a deadline was not met.

3. On June 26, 2015, the operator appealed the second Order through counsel.

4. Upon its own motion and pursuant to K.S.A. 77-551(c), the Commission finds

that a Prehearing Officer should be designated in this proceeding to address any matters listed in

K.S.A. 77-517(b), and that a prehearing conference should be scheduled.

THEREFORE, THE COMMISSION ORDERS:

A. The Prehearing Officer in this proceeding shall be Lane R. Palmateer, Counsel, Kansas Corporation Commission, 266 N. Main, Ste. 220, Wichita, Kansas 67202, telephone number 316-337-6200, email address <u>l.palmateer@kcc.ks.gov</u>.

B. A Prehearing Conference is scheduled for Tuesday, August 4, 2015. The Prehearing Conference shall begin at 11:00 a.m. and end by 12:00 p.m., at the Commission's offices, 266 N. Main St., Ste. 220, Wichita, Kansas 67202. Telephonic attendance may be permitted upon advance request. The Prehearing Conference will focus on the development of a procedural schedule for this docket.

C. At the Prehearing Conference, parties shall be prepared to discuss deadlines for filing testimony and briefs, discovery procedures, scheduling of a hearing with the Commission, and any other issues that will promote the orderly and prompt resolution of this proceeding.

D. At the Prehearing Conference, without further notice, this proceeding may be converted into a conference hearing or a summary proceeding for disposition of this matter as provided by the Kansas Administrative Procedure Act ("KAPA"). <u>Any party that fails to attend or participate in the Prehearing Conference, hearing, or other stage of this proceeding shall be held in default under the KAPA.</u>

E. <u>Pursuant to K.A.R. 82-1-228(d)(2), corporations must enter an appearance via an</u> <u>attorney. If a corporation fails to enter an appearance via an attorney prior to the Prehearing</u> Conference, it shall be held in default under the KAPA.
