



with its findings, VPS endorsed Intrado filing an affidavit of a corporate officer attesting to the Company taking corrective action to permit it to correctly report the KUSF surcharge collected from customers in Box C of the CRWs and the date procedures were put into place to correct this deficiency. VPS advised having Intrado directed to take corrective action within 60 days of the Order Adopting the Audit Report.

3. The Commission issued an Order on June 23, 2022, adopting the recommendations of VPS. On July 27, 2022, VPS issued a Compliance Report indicating Intrado had filed True-up Reports for March 2019 through February 2021 to correct Box C of the CRWs, and filed an Annual Interrogatory for 2020 on June 8, 2022. VPS noted that Intrado had submitted a letter attesting to filing the True-up Reports and the 2020 Annual Interrogatory. VPS also stated Intrado had fulfilled all the requirements of the Order and was in compliance with Commission directives.

4. The Commission has reviewed VPS' Compliance Report filed in this matter and finds it should be adopted, closing the Docket.

**IT IS THEREFORE, BY THE COMMISSION ORDERED THAT:**


A. The Commission accepts and adopts Vantage Point Solutions' Compliance Report filed July 27, 2022, and determines the Docket be closed.

B. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.
