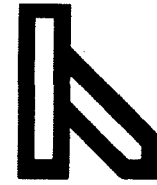

Re: Request for Hearing (Docket No. 15-CON-357-CPEN)

Dear Mr. Day:

PostRock MidContinent Production LLC ("Operator") hereby requests that a hearing be held concerning the Penalty Order dated October 28, 2014 (mailed November 4, and received by us on November 7) in the above-referenced cause. Please note that contemporaneously herewith Operator is likewise requesting a hearing of the Penalty Order dated October 28, 2014 (mailed October 30, 2014, and received by us on November 3) in cause No. 15-CONS-336-CPEN.

The grounds for both requests are the same. We received the Notification of Violation for both the Surface Pit Closure Forms (CDP-4) and the Waste Transfer Forms (CDP-5) in early October. Each contained a compliance deadline of October 16, 2014. Unfortunately, the Notifications were mishandled in our office and were not placed on the calendar. Consequently, the requisite forms were not filed by October 16. When our error was discovered, Jennifer Beal of our Chanute office immediately contacted Kathy Haynes of the KCC by telephone in the morning on October 24. Jennifer explained what had happened and advised that she would be immediately filing all of the requisite CDP-4 and CDP-5 forms. She in fact had everything filed electronically and approved by the KCC by 9:50 a.m. that day. Hence, by the time the Penalty Orders were entered on October 28, all of the delinquent forms had in fact been filed.

It should additionally be noted that all 18 of the wells for which the CDP-5 forms were not timely filed are also on the list of wells for which the CDP-4 forms were



delinquent. Therefore, the KCC is in essence imposing a double penalty concerning those 18 wells.
