**NOTICE OF UNANIMOUS SETTLEMENT AND REQUEST TO ENLARGE BY  
ONE DAY THE TIME TO FILE A WRITTEN SETTLEMENT AGREEMENT AND  
TO SUBMIT SETTLEMENT TESTIMONY**

COME NOW Evergy Kansas Central, Inc. and Evergy Kansas South, Inc. (collectively referred to as “Evergy Kansas Central” or “EKC”) and hereby notify the State Corporation Commission of the State of Kansas (“Commission”) that on Thursday, July 10, 2025, the Parties reached a unanimous settlement in principle resolving all contested issues and other matters in the above-captioned general rate case.

After agreeing in principle to the terms of the unanimous settlement, the Parties have been working diligently to memorialize those terms in a written settlement agreement. However, the parties anticipate they may need more time to finalize the written agreement and to prepare testimony in support of the agreement than was originally allotted in the *Order Setting Procedural Schedule* entered by the Commission on February 13, 2025 (“Procedural Order”).<sup>1</sup>

<sup>1</sup> Requesting a one-day expansion of time to file a written settlement agreement and to submit settlement testimony to the Commission was proposed at the settlement conference on July 10, 2025. No Party objected to the proposed request.

Wherefore, on behalf of the Parties to the unanimous settlement, EKC respectfully requests the Commission modify the Procedural Order to allow the Parties to file their written settlement agreement on or before **Tuesday, July 15, 2025 at 5 p.m.**, and to submit settlement testimony on or before **Thursday, July 17, 2025 at 5 p.m.** No additional adjustments to the Procedural Order are requested by the Parties.<sup>2</sup>
