MOTION TO DISMISS APPLICATION AND CLOSE DOCKET

Staff of the Kansas Corporation Commission (Staff and Commission, respectively) moves the Commission to issue an order dismissing the application and closing the docket in this matter. In support of its motion, Staff states as follows:

- 1. On April 23, 2024, Jordan Oil Management Inc. (Operator) filed an application seeking an exception to the 10-year time limitation of K.A.R. 82-3-111 for its Latta A Lease #9 well, API #15-191-20581 (Subject Well).
- 2. Upon review of the application, Legal Staff found an issue as Operator had not filed affidavits of publication from the Wichita Eagle or official county newspaper, indicating non-compliance with K.A.R. 82-3-135a(d).
- 3. On June 5, 2024, Staff sent a letter to Operator requesting that the issues with its application be corrected by July 5, 2024. Staff's letter also states failure to correct the issues by the deadline would result in Staff filing a motion to dismiss the application. To date, Operator has not filed affidavits of publication from the Wichita Eagle and official county newspaper.
