The KS USF Traffic Study contains highly proprietary and confidential commercial and financial information, the disclosure of which to competitors, or potential competitors, would be highly detrimental to the Company. Specifically, page one breaks out the percentage of intrastate traffic on a monthly basis.

The information is only available to a subset of employees of the Company and its legal and financial agents.
