
QUESTION: For each census block SWBT is requesting ETC relinquishment, please provide a listing of all facilities-based non-Lifeline-only ETCs designated in that census block.

ANSWER: In Attachment 2, AT&T Kansas has provided a list of all ETCs designated in each AT&T Kansas exchange, including both Census Blocks where AT&T Kansas is relinquishing its ETC designation and Census Blocks where it is retaining its ETC designation. Federal law requires that, so long as there is more than one ETC serving an area, a state *shall* permit a carrier to relinquish its ETC designation. 47 U.S.C. § 214(e)(4) and 47 C.F.R. § 54.205. Nothing in the statute or FCC rules differentiates between Lifeline-only and non-Lifeline only ETCs. So long as another ETC is present, a state commission *must* allow a carrier to relinquish its ETC designation upon request. The KCC itself has adhered to this framework when it previously considered a non-lifeline-only ETC relinquishment filing. Recently, the KCC granted Sage's wireline ETC relinquishment application in Docket No. 17-SAGT-100-ETC, noting, among other things, that "twenty-three carriers have been designated as competitive ETCs" in all or some of the areas covered by Sage's wireline ETC designation in Docket No. 03-SAGT-867-ETC. Absent FCC forbearance, which the FCC has only granted for Lifeline-only ETCs, all non-Lifeline-only ETCs must be at least partially facilities-based as the FCC prohibits states from designating carriers as ETCs that offer services supported by federal universal service support mechanisms exclusively through the resale of another carrier's services. 47 C.F.R. § 54.201(i).
