MEMORANDUM

Dear Ms. Thomas,

K.S.A. 66-104(a) provides a definition of "public utility" and subjects such public utilities to regulation by the Kansas Corporation Commission (Commission). K.S.A. 66-104(e) provides for an exemption from regulation for certain generation facilities which are placed in service on or after January 1, 2001, and are not in the rate base of an electric public utility, cooperative, or municipally owned electric utility. This exemption is available "at the option of an otherwise jurisdictional utility."

On February 11, 2015, Ensign Wind, LLC, filed a notice to the Commission of its decision to opt out of public utility regulation pursuant to K.S.A. 66-104(e). The notice was docketed as 15-ENSW-372-WND. Commission Staff believes the notice is an appropriate method for Ensign Wind to exercise its option to exempt itself from public utility status. However, there is no process in the statute or regulations for Commission action regarding the exemption. Therefore, this docket may be closed without further action by the Commission.
