In the Matter of the Audit of Google Fiber North America by the Kansas Universal Service Fund (KUSF) Administrator Pursuant to K.S.A 2018 Supp. 66-2010(b) for KUSF Fiscal Year 22, March 2018-February 2019.

Dear Ms. Retz:

On April 21, 2020, Kansas Corporation Commission (KCC or Commission) issued an Order adopting GVNW Consulting, Inc.'s (GVNW) Audit Report and directed Google Fiber North America (Google Fiber or Company) to: (1) file audit True-up Reports for March 2016 through February 2019 and CRWs for the period March 2019 through January 2020 to correct its KUSF reports using the VoIP Safe Harbor rate and reflecting the surcharge amounts collected from customers in Box C of the CRWs; and (2) file an affidavit from a corporate officer attesting to changes it made to its procedures to correctly report assessments collected from customers in Box C of the CRWs and the date the procedures were implemented. These actions were to be taken within 60-days of the issuance of the Order.

On June 12, 2020, the Company filed audit True-up reports for March 2016 through February 2019 and CRWs for March 2019 through January 2020 to correct its reports using the correct VoIP Safe Harbor rate and reflecting the surcharge amounts collected from customers in Box C of the CRWs. On June 19, 2020, Google Fiber provided GVNW with an affidavit signed by an officer of the Company attesting to changes it made to its procedures to correctly report assessments collected from customers in Box C of the CRWs. GVNW filed the Company's affidavit on June 22, 2020. GVNW found no discrepancies with Google Fiber's compliance with the April 21, 2020 Order.

GVNW recommends that the Commission determine Google Fiber is in compliance with the Commission's Order and that Docket No. 20-GFNV-066-KSF be closed.
