NOTICE OF ADDENDUM TO ENERGY SUPPLY AGREEMENT (PUBLIC VERSION)

HollyFrontier El Dorado Refining LLC ("Frontier") and Kansas Gas and Electric Company d/b/a Westar Energy ("Westar") jointly file this Notice of Addendum to Energy Supply Agreement. Frontier and Westar state to the State Corporation Commission of the State of Kansas ("Commission") as follows:

1. On August 28, 2018, Frontier and Westar filed a Joint Application requesting approval of a proposed Energy Supply Agreement ("ESA" or "Agreement") between Frontier and Westar.

2. Frontier currently takes service from Westar under an Energy Supply Agreement ("ESA") that was approved by the Commission on January 2, 2013, in Docket No. 12-KG&E-718-CON, and extended one year by the Commission in Docket No. 18-KG&E-112-CON. The ESA was set to expire on January 2, 2019. On December 6, 2018, the Commission issued an Order extending the current ESA until the issuance of a final Commission Order in this docket.

3. Section 5.1 of the proposed ESA states that "[t]he rates set forth in this Section shall be changed to the rates approved by the KCC in Docket No. 18-WSEE-328-RTS." Section 5.7.F. of both the currently effective ESA and the proposed ESA further provide that the contract rates charged to Frontier may be adjusted to reflect the same increase or decrease approved for the ILP rate class in a Westar rate case.

4. On September 27, 2018, the Commission approved new rates for Westar customers, including the ILP rate class, in Docket No. 18-WSEE-328-RTS. In compliance with that order, Westar submitted in the general rate case docket an addendum to the currently effective ESA, which set forth the new Frontier rates.

5. Westar and Frontier now submit the attached Addendum to the proposed ESA setting forth Frontier's rates, as adjusted in the Westar rate case. If the ESA is approved by the Commission, these will be the effective rates charged to Frontier under the contract.

WHEREFORE, Westar and Frontier respectfully submit the attached Addendum to Energy Supply Agreement for the Commission's consideration.

Addendum to Contract

Pursuant to Article 5, paragraph 5.1 A and 5.1 B of the Energy Supply Agreement between Kansas Gas and Electric Company and Frontier El Dorado Refining Company, pending Commission approval in 19-KG&E-091-CON, the following rates will apply to service effective with approval by the Kansas Corporation Commission. The below rates reflect base rate changes approved in Docket No. 18-WSEE-328-RTS, which adjusted the contract rates pursuant to Article 5, paragraph 5.7 F of the Energy Supply Agreement.

ARTICLE 5 - RATES

5.1 Beginning on the Effective Date of this Agreement, Customer shall pay monthly Company for all Energy provided hereunder. Pricing of such purchased Energy shall be established pursuant to the then applicable rates (cents per kWh) specified in the following monthly rate schedule:

- A. From October 1 through May 31 (8 winter months):
 - i. First Block 6,500,000 kWh per month
 - ii. Second <u>Block 10,000</u>,000 kWh per month
 - iii. Third Block 20,000,000 kWh per month
 - iv. Fourth Block all additional kWh per month
- B. From June 1 through September 30 (four summer months):
 - i. First Block 6,500,000 kWh per month
 - ii. Second <u>Block 30,000</u>,000 kWh per month
 - iii. Third Block all additional kWh per month
