AT&T KANSAS' MOTION FOR ENLARGEMENT OF TIME TO RESPOND TO STAFF REPORT AND RECOMMENDATION

COMES NOW Southwestern Bell Telephone Company, LLC d/b/a AT&T Kansas ("AT&T Kansas"), pursuant to K.A.R. 82-1-217(b), K.A.R. 82-1-218 and K.A.R. 82-1-219, and respectfully submits its Motion for Enlargement of Time to Respond to Staff's Report and Recommendation in the instant proceeding. In support of its Motion, AT&T Kansas shows the Commission as follows:

- 1. AT&T Kansas filed its Petition for an Order Confirming Relinquishment of its Designation as an Eligible Telecommunications Carrier ("ETC") in Specified Areas (hereinafter the "Application"), in this proceeding on March 27, 2025.
- 2. AT&T Kansas' Application requested a final Commission Order confirming relinquishment of its ETC designation in the specified areas on or before October 1, 2025, and confirming AT&T Kansas' relinquishment of its ETC designation in the specified census blocks effective November 1, 2025.

- 3. On October 27, 2025, the Staff of the Kansas Corporation Commission filed their Report and Recommendation ("Staff's R&R"), discussing the Staff's analysis of AT&T Kansas' request, and Staff's recommendations to the Commission for the disposition of the proceeding.
- 4. AT&T Kansas' response to the Staff R&R is due on or before Thursday, November 6, 2025. AT&T Kansas requests the response time be enlarged to Friday, November 21, 2025.
- 5. AT&T Kansas' Motion for Enlargement is timely filed, and is AT&T Kansas' first such request.
- 6. Counsel for AT&T Kansas' has discussed its request with counsel for Staff, Ahsan Latif, and was informed that Staff has no objection to AT&T Kansas' requested enlargement of time.

WHEREFORE, for these reasons, AT&T Kansas respectfully requests that the Commission order the enlargement of time for the submission of AT&T Kansas' response to the Staff R&R to and including Friday, November 21, 2025.
