NOTICE AND EXPLANATION OF SERVICE

The Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively) files this *Notice and Explanation of Service*, as Staff stated it would in its February 19, 2018 filing.

I. Background

1. On November 21, 2017, the Commission issued an *Order Opening General Investigation*, to examine legal issues pertaining to notice requirements for injection applications filed between October 2008 and the present.

2. Pursuant to Paragraph 8 of the Commission's November 21, 2017 order, Staff was directed to provide a list of all underground injection well applications going back to October 2008, where the applicant's publication notice informed persons that they only had 15 days from publication to file an objection or protest, and to provide a sub-list of those applications that were approved by the Commission, including various other data pertaining to the applications.

3. On February 19, 2018, Staff timely provided the data requested by the Commission through its filed *Report and Recommendation*. Simultaneously, Staff served notice of the *Report and Recommendation* electronically upon all members of the Oil and Gas Advisory Committee. Noting that Staff was presently the only party to the proceeding, Staff stated its intention to nevertheless also serve all operators for whom applications for injection authority

were approved, and its intention to file a follow-up notice to inform the Commission when such service was complete.

4. Since February 19, 2018, Staff has reviewed the data appropriately provided to the Commission pursuant to the Commission's November 21, 2017 order. Staff has determined that subsequent to the issuance of some of the injection permits, certain leases and wells have changed names, have been plugged, and/or have changed operatorship. Staff has attached Exhibit B to this filing, identical to Staff's Exhibit A submitted February 19, 2018, with two distinctions: (1) highlighted in gray is any permit in which Staff has noted a change in operatorship or other pertinent data; and (2) removal of any application in which a permit was not issued.

5. Noting that no legal obligation regarding service presently exists in this docket, Staff believes it would be most useful to serve notice only upon the present operators of unplugged wells with permits listed on Staff's Exhibit B.

6. Accordingly, copies of the Commission's November 21, 2017 order, Staff's February 19, 2018 filing, and this filing explaining service, have today been served by Staff upon every operator currently listed as an operator of an unplugged well with a permit listed in Staff's Exhibit B.¹ Specifically, Staff has served every operator listed as the "original filing operator" on Staff's Exhibit B, except where there is now an updated "current operator," in which case Staff has served that entity instead.

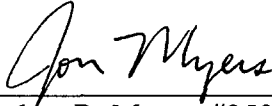

Staff renews its February 19, 2018, suggestion that the Commission-ordered deadlines for entries of appearance, petitions for intervention, and submission of briefs be tolled to commence with the filing of this *Notice*; however, Staff cautions all affected operators, interested parties, and the general public that the Commission has not ruled on this suggestion.

¹ Operators were served at the most recent address provided by operators as part of the annual licensing process.

Such persons should consult the Commission's November 21, 2017, *Order Opening General Investigation* if such persons have questions regarding any current deadlines.

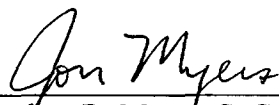

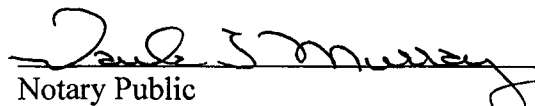

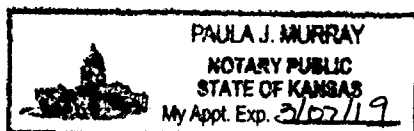
