3. On July 17, 2018, the Commission Staff (Staff) submitted a Report and Recommendation, dated July 12, 2018, recommending the Commission grant the Telmex Application and approve the requested name change to Claro on the interexchange certificate previously granted in Docket 01-590.

4. The Commission adopts Staff's analysis and recommendations of July 12, 2018, as stated in the Report and Recommendation, which is attached hereto and made a part hereof by reference, and finds that the Telmex Application should be granted. The Commission further finds that the requested name change to Claro under the Telmex Certificate of Convenience and Authority to provide Intrastate Interexchange Telecommunications Service will promote the public convenience and should be approved. As part of the approval process, the Commission directs Claro to notify it regarding any change in address or contact telephone numbers, file timely annual reports, maintain current registration with the Kansas Secretary of State's office and pay all Commission and KUSF assessments in a timely manner.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The Telmex USA, L.L.C. Application filed in this matter on July 2, 2018, is hereby granted and the request for a name change to Claro Enterprise Solutions, LLC, under its Certificate of Convenience and Authority issued in Docket No. 01-TMUC-590-COC is hereby granted.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529 (a) (1).¹

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order, or orders, as it may deem necessary.

EXECUTIVE SUMMARY:

On July 2, 2018, Telmex USA, L.L.C. (Telmex) filed an Application requesting to change the Company's name to Claro Enterprise Solutions, LLC (Claro). Staff recommends Commission approval of this filing.

BACKGROUND:

The Commission approved the Company's IXC Certificate in Docket 01-TMUC-590-COC in an Order dated March 20, 2001. Claro is registered with the Kansas Secretary of State and the name change is on file. The account status is currently "Active and in Good Standing" for Claro.

ANALYSIS:

The Commission derives its authority to supervise telecommunications public utilities from K.S.A. 66-1,188. The Commission derives its authority to certificate and de-certificate public utilities from K.S.A. 66-131. The Commission must determine whether the proposed company name change would promote the "public convenience." See K.S.A. 66-131; K.S.A. 66-136.

The Company is in compliance with respect to Commission Assessments and Annual Report filing requirements.

RECOMMENDATION:

Staff recommends the Commission approve the request to change the Company name from Telmex to Claro on the IXC Certificate the company has on file with the Commission. Staff reviewed the Application and available documentation and finds that the name change should promote the public convenience.
