Dear Ms. Petersen-Klein:

In Order No. 1 of the above referenced docket, the Kansas Corporation Commission (KCC or Commission) ordered GVNW Consulting, Inc. (GVNW) to commence an audit of Broadband Dynamics, LLC (Broadband Dynamics or Company). On May 14, 2012, GVNW filed a public version of the final audit report that identified one (1) KUSF-related audit deficiency and one (1) non-KUSF related issue and recommended a refund of \$55.66 of one-time equal bill credits to its current customers with the KUSF refunding \$55.66 to the Company to correct the following KUSF reporting deficiency. An Order addressing GVNW's May 14, 2012, filing has not yet been issued or a refund by the KUSF Administrator been issued to the Company.

On June 11, 2012, Broadband Dynamics provided an affidavit (Attachment A) to verify that it issued \$55.66 in total refunds via one-time equal bill credits to existing Kansas customers. GVNW also reviewed additional customer bills to confirm that the refund occurred.

Therefore, GVNW verifies that Broadband Dynamics is in compliance with the KUSF-related audit findings.


