STATUS UPDATE TO COMPLIANCE AGREEMENT

On July 21, 2020, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket. The Agreement originally addressed 27 wells, requiring Operator to obtain compliance at three wells per quarter beginning September 30, 2020.¹ A total of 48 wells have been added to the Compliance Agreement, extending the final compliance deadline to September 30, 2026. To date, Operator has brought 51 wells into compliance with the terms of the Agreement. The Agreement provides that it may be amended to include additional wells with the written consent of the District Supervisor.²

The District #3 Supervisor recommends amending the Agreement to include the C Heim #5, API #15-103-20450; C Heim #6, API #15-103-20599; C Heim #9, API #15-103-20716; C Heim #11, API #15-103-20819; C Heim #12, API #15-103-20892; C Heim #13, API #15-103-21095; Caraway #1, API #15-103-20895; Caraway #2, API #15-103-20956; Heim C #1-31, API #15-103-20314; Heim C #7, API #15-103-20672; Heim C #14, API #15-103-21096; Hill-Kimball Unit #1, API #15-103-21165; J Heim #5, API #15-103-20891; and Wunderly #5-26, API #15-011-23244 wells (Subject Wells). Operator has indicated it is not opposed to the addition of the Subject Wells to the Agreement. Further, Staff recommends the final compliance deadline be extended to December 31, 2027.
