



Commission Staff is without sufficient time to fully review, consider, and analyze the Application.

3. The Commission finds and concludes that suspension of the effectiveness of the Joint Application and deferral of its effective date is required to allow sufficient time for full investigation of this matter. The Joint Application shall be suspended for a period of 240 days from the date it was filed, July 16, 2015, until Monday, March 14, 2016,<sup>1</sup> pursuant to K.S.A. 66-117(c). A final order may be issued before such date.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

A. Pursuant to K.S.A. 66-117(c), the Application in the above-captioned docket shall be suspended, and the effective date deferred, until March 14, 2016.

B. Parties have 15 days, plus three days if service is by mail, from the date of service of this Order in which to petition the Commission for reconsideration.<sup>2</sup>

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further order, or orders, as it may deem necessary and proper.
