**ORDER GRANTING ADMISSION OF DOUGLAS L. HEALY,
TERRY M. JARRETT, AND HEATHER STARNES PRO HAC VICE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

1. On January 19, 2017, the Commission issued in this docket its *Order Opening General Investigation* (Order), seeking comments from the parties as to whether annual or periodic reporting by the Southwest Power Pool (SPP), and Kansas utilities that participate in SPP, is in the public interest.¹

2. On February 13, 2017, W. Robert Alderson, an attorney in good standing and licensed to practice law in the State of Kansas, filed a Motion for Admission of Douglas L. Healy, Terry M. Jarrett, and Heather Starnes *Pro Hac Vice* as attorneys on behalf of the Kansas Municipal Energy Agency (KMEA), pursuant to Kansas Supreme Court Rule 116. Mr. Alderson stated he will sign all pleadings and other papers filed with the Commission and will be actively engaged in the case and present for all appearances, to the extent required by the Commission.

3. On February 28, 2017, Mr. Alderson filed a Revised Motion for Admission of Douglas L. Healy, Terry M. Jarrett, and Heather Starnes *Pro Hac Vice*. The Revised Motion

included the required Verified Applications signed by each of the three aforementioned applicants, pursuant to Supreme Court Rule 116(e).² All three applicants have verified they are in good standing and licensed to practice law in their respective bars. The three applicants are not currently, nor have they ever been, the subject of public discipline, including but not limited to suspension or disbarment, in any jurisdiction. The Verified Applications list Mr. Healy's address as 3010 E. Battlefield, Suite A, Springfield, MO 65804; Mr. Jarrett's address as 514 East High Street, Suite 22, Jefferson City, MO 65101; and Ms. Starnes' address as 12 Perdido Circle, Little Rock, AR 72211.

4. The Commission finds that all three applicants have met the requirements of Supreme Court Rule 116 and shall be granted admission *pro hac vice* to appear on behalf of KMEA in this docket.
