shut-in since September 9, 1992, the Steckel

since June 7, 1993. All wells will undergo and  
pass a KCC witnessed mechanical integrity  
test prior to the applications being filed.  
Any persons who object to or protest  
this application shall be required to file their  
objections or protests with the Conservation  
Division of the State Corporation Commission  
of the State of Kansas within fifteen (15)  
days from the date of this publication. These  
protests shall be filed pursuant to Commission  
regulations and must state specific reasons  
why the grant of the application would be  
detrimental to natural resources of the state  
of Kansas.
