

ORDER GRANTING CURB'S PETITION TO INTERVENE

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and records and being fully advised in the premises, the Commission finds and concludes as follows:

1. On March 10, 2011, Staff filed a report recommending the Commission open a docket to review the Kansas Lifeline Service Program.
2. On March 14, 2011, the Citizens' Utility Ratepayer Board (CURB) filed a petition to intervene in Staff's recommended docket. CURB represents residential and small commercial ratepayers, pursuant to K.S.A. 66-1223, and notes that "[t]he rates paid and the service received by those customers will or may be affected by any Commission order or activity in this proceeding."
3. Pursuant to K.A.R. 82-1-225(a) the presiding officer in a matter shall grant a petition for intervention if:
 - (1) The petition is submitted in writing to the presiding officer with copies mailed to all parties named in the presiding officer's notice of the hearing, at least three days before the hearing;

(2) the petition states facts demonstrating that the petitioner's legal rights, duties, privileges, immunities or other legal interests may be substantially affected by the proceeding or that the petitioner qualifies as an intervenor under any provision of law; and

(3) the presiding officer determines that the interests of justice and the orderly and prompt conduct of the proceedings will not be impaired by allowing the intervention.

4. The Commission notes that a notice of hearing has not been issued in the matter, CURB properly mailed copies of the petition to intervene to Staff counsel. Further, CURB's petition states facts demonstrating that CURB's constituents' legal rights, duties, privileges, immunities or other legal interests may be substantially affected by the proceeding.

5. The Commission finds and concludes that all conditions for granting intervention under K.A.R. 82-1-225(a) have been fulfilled. The petition to intervene demonstrates that CURB's constituents will be affected by the proceeding, and due to the infant nature of the proceeding, granting the petitions to intervene will not impair the orderly and prompt conduct of the proceedings, and the interests of justice will be served by the intervention.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The Petition to Intervene filed by CURB is granted.

B. The parties have fifteen days, plus three days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 2010 Supp. 77-529(a)(1).

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.
