JOINT MOTION FOR APPROVAL OF PROCEDURAL SCHEDULE

COME NOW, the Staff of the State Corporation Commission of the State of Kansas (“Staff” and “Commission” respectively), along with Kansas City Power & Light Company (“KCPL”), the City of Mission (“Mission”) and the Citizens’ Utility Ratepayer Board (“CURB”) (collectively, “Joint Movants”) and respectfully request that the Commission adopt the proposed procedural schedule agreed to by the Joint Movants. In support of their request, Joint Movants state as follows:

1. On March 1, 2007, KCPL filed an application seeking permission to make certain changes in its rates for electric service.
2. On March 2, 2007, CURB filed a Petition to Intervene in the above captioned docket.
3. On March 14, 2007, the Commission granted CURB’s Petition to Intervene.
4. On March 20, 2007, Mission filed a Petition to Intervene in the above captioned docket.
5. On April 2, 2007, The Commission granted Mission’s Petition to Intervene.
6. The Joint Movants have conferred and have agreed upon the following procedural schedule:

Final Order



7.
