

JOINT MOTION FOR ESTABLISHMENT OF PROCEDURAL SCHEDULE

COMES NOW the Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively), the Citizens’ Utility Ratepayer Board (CURB) and Suburban Water, Inc., d/b/a Suburban Water Company (Suburban) and for their joint motion for establishment of a procedural schedule states as follows:

1. On March 24, 2010, Suburban filed its request for Commission approval of a proposed purchased water adjustment and its request for Commission approval of an automatic meter reading system surcharge tariff. The Commission suspended the effectiveness of Suburban’s filings for 240 days pursuant to K.S.A. 66-117, until November 14, 2010, to allow time for Staff to investigate Suburban’s application.

2. On March 26, 2010, CURB filed its petitions to intervene in both dockets and the Commission granted the petitions on April 7, 2010.

2. Staff, CURB, and Suburban have reached an agreement on the following procedural schedule to govern the proceeding and jointly move the Commission to issue an order adopting the procedural schedule:

July 22, 2010	Public hearing
July 30, 2010	Staff, CURB direct testimony due
August 13, 2010	Suburban Rebuttal testimony due
August 20, 2010	Discovery ends
August 30, 2010	Pretrial motions, if any, due
September 1, 2010	Prehearing/settlement conference (informal)
September 3, 2010	Public comment period ends
September 8 & 9, 2010	Evidentiary hearing
September 24, 2010	Suburban initial brief due
October 8, 2010	Staff, CURB responsive brief due
October 15, 2010	Suburban reply brief due
November 14, 2010	Commission order due


3. The parties agree that testimony and briefs shall be served on the other parties to the dockets, and on the prehearing officer, no later than 3:00pm on the dates due and that, as a result, hard-copy service of such testimony and briefs shall not be required. A paper original and seven copies of such testimony or briefs shall be filed with the Commission in the docket no later than 5:00pm on the dates due, as required by K.A.R. 82-1-215(a).

WHEREFORE Staff, CURB, and Suburban requests the Commission adopt the agreed-upon procedural schedule and for such other and further relief as the Commission deems just and proper.



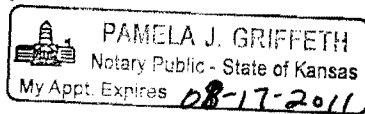


