**MOTION FOR WAIVER**

COMES NOW Howison Heights, Inc., ("Howison"), and pursuant to K.A.R. 82-1-231(i) files this Motion for Waiver of several of the filing requirements for rate proceedings under K.A.R. 82-1-231b. In support of its Motion for Waiver, Howison states as follows:

1. Howison is a Kansas corporation with its principal place of business located at 1212 Meyer Drive, Salina, Kansas 67401. Howison is a very small, privately owned water public utility serving approximately 62 residential customers. Howison is a public utility as defined by K.S.A. 66-104 and 66-1,230 and is subject to the jurisdiction of the Kansas Corporation Commission ("Commission"). Howison has received the appropriate certificates of convenience from the Commission to provide water service to customers located in its service territory, which covers an area north of the City of Salina, Kansas, all in Saline County.

2. On December 12, 2012, pursuant to the requirements set forth in K.A.R. 82-1-214, Howison filed its letter of intent to file a rate case with the Commission to request a change in its rates and tariffs under K.A.R. 82-1-231b. The main reason for the requested rate increase is to recover the normal cost of service items such as operating and maintenance expenses.

3. Howison is requesting that the Commission grant it a waiver of those rate case filing requirements contained in K.A.R. 82-1-231b that it has not included in its rate case application in

order to reduce the cost of filing this application.

4. Howison has included the following information in its rate case application:





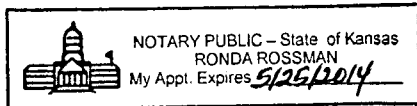
