
**JOINT MOTION TO ESTABLISH PROCEDURAL SCHEDULE**




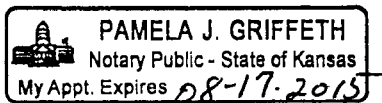
