NOTICE OF COMMUNICATION

1. On November 18, 2015, and at the request of Kansas City Power & Light Company (KCP&L), Commissioner Apple met with representatives from KCP&L at the Commission's Office in Topeka, KS. The meeting took place following the Commission's Order Denying KCP&L's Petition for Reconsideration but prior to KCP&L's filing of the appeal of the Commission's final order in this docket.

2. The topic of conversation centered on Commissioner Apple's concerns regarding KCP&L's future treatment of its all-electric residential customer class and the rate differential between Kansas' electric rates and the rates of its neighboring states. At no time during the course of the meeting were any issues discussed which were set for hearing or awaiting a Commission decision. KCP&L did not request the Commission to take any action nor did Commissioner Apple request KCP&L to take any specific action. However, out of an abundance of caution, the Office of General Counsel and KCP&L jointly give notice of the communication.
