**PREHEARING OFFICER ORDER REGARDING ELECTRONIC SERVICE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. Operator has requested hearings on the penalty orders issued in the captioned dockets.

These matters have been consolidated for hearing on a common record.<sup>1</sup>

2. At a May 28, 2020, prehearing conference, counsel for all parties consented to the electronic service of all documents<sup>2</sup> and orders.<sup>3</sup> Therefore, the Prehearing Officer directs that service of all documents and orders upon counsel may be made by email. To the extent practicable, any electronically served document or order shall be attached to the email and served in pdf format. Service of orders is complete upon transmission.<sup>4</sup> Parties are encouraged to make sure large pdf files do not result in delivery failure and to work together to resolve any email-based service issues.

4. The Commission shall continue to serve Operator itself copies of all orders via mail.
