STAFF'S MOTION TO CHANGE DOCKET SUFFIX TO TAR

The Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively) hereby moves the Commission to change the Docket No. in this matter from 21-EKME-320-ACT to 21-EKME-320-TAR. In support thereof, Staff states the following:

1. On February 24, 2021, Evergy filed an Application seeking approval of tariffs, budgets, accounting authority, and a predetermination of prudence with respect to its proposed Transportation Electrification Portfolio.

2. K.A.R. 82-1-212 mandates that each matter coming before the Commission be given a docket number and descriptive title.

3. The Commission opened this Docket with the designation of 21-EKME-320-ACT.

4. Staff, having reviewed the full Application, believes that the accounting authority aspect of this docket is of less focus and concern relative to the tariff/ratemaking requests being made. Therefore, for administrative tracking purposes and descriptive accuracy, Staff requests the Commission change the Docket No. in this matter to 21-EKME-320-TAR.


