**NOTIFICATION OF MERGER; APPLICATION FOR TRANSFER OF EXISTING
CERTIFICATES OF PUBLIC CONVENIENCE AND AUTHORITY, AND
NAME CHANGE TO AT&T ENTERPRISES, INC.**

COME NOW AT&T Corp. and AT&T Enterprises, Inc., pursuant to K.S.A. 66-1,188 and K.S.A. 66-2005(z)(1), and hereby notifies the Kansas Corporation Commission of the following:

**NOTIFICATION OF MERGER OF
AT&T CORP. AND AT&T ENTERPRISES, INC.**

1. AT&T Corp., a New York corporation and wholly owned subsidiary of AT&T Inc., is properly registered to do business in the state of Kansas as a foreign corporation and is active and in good standing with the Kansas Secretary of State's office. AT&T Corp. holds Certificates of Convenience and Authority ("CCA") previously issued by the Commission.¹

2. AT&T Enterprises, Inc. ("AT&T Enterprises"), is a Delaware corporation and wholly owned subsidiary of AT&T Inc., with its principal office located at 208 Akard St., Dallas, Texas 75202. AT&T Enterprises is properly registered to do business in the

state of Kansas as a foreign corporation.² AT&T Enterprises is also active and in good standing with the Kansas Secretary of State's office.³

3. Pursuant to its CCA and Kansas law, AT&T Corp. hereby notifies the Commission that on or about May 1, 2024, it will be merging into and with AT&T Enterprises. As a result, AT&T Corp. will be merged out of existence and AT&T Enterprises will be the surviving entity. Accordingly, AT&T Corp. and AT&T Enterprises together desire that effective May 1, 2024, AT&T Enterprises may begin serving the Kansas customers now served by AT&T Corp.

4. AT&T Inc. is undertaking an internal restructuring project to rationalize its corporate structure, which is complex, with over 400 subsidiaries. The merger of AT&T Corp. and AT&T Enterprises will help to streamline AT&T's corporate structure, resulting in greater operational efficiencies.

APPLICATION FOR TRANSFER OF AT&T CORP. CERTIFICATES OF CONVENIENCE AND CHANGE OF NAME

5. AT&T Corp. requests the Commission transfer its CCA to AT&T Enterprises and that the changed corporate structure and name, AT&T Enterprises, Inc., be noted and reflected by the Commission in all company references, including the CCA and all future proceedings, effective May 1, 2024.

6. The outlined corporate reorganization will not result in any change in the ultimate ownership, control, personnel, management, or day-to-day operations now used to serve AT&T Corp.'s customers in Kansas.⁴ AT&T Enterprises will continue to

use the same network, maintenance, provisioning systems and procedures, and the same customer care operations that are currently used to provide services to these customers. The transaction will be entirely transparent to AT&T Corp.'s customers. The transaction will also not result in any change to the rates, terms, and conditions applicable to the services now provided to AT&T Corp.'s customers, other than a change in the name of the customer-serving entity.

WHEREFORE, AT&T Corp. and AT&T Enterprises, Inc., respectfully request an Order of the Commission granting AT&T Corp.'s Application requesting that effective May 1, 2024: (1) it's changed corporate structure and name, AT&T Enterprises, Inc., be noted and reflected by the Commission in all company references, including on its CCA; and, (2) that it's CCA be transferred to AT&T Enterprises, Inc., to operate as a provider of telecommunications services within the state of Kansas.

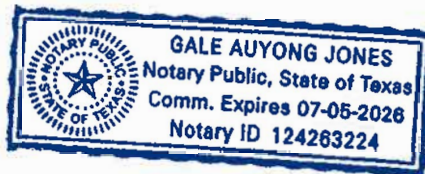


