**NOTICE AND APPLICATION FOR NAME CHANGE OF  
AT&T ENTERPRISES, INC.**

COMES NOW AT&T Enterprises, Inc. (“AT&T Enterprises”), pursuant to K.S.A. 66-1,188 and K.S.A. 66-2005(z)(1), and hereby submits its Notice and Application to change the company’s name on its Certificate of Convenience and Authority (“COC”). In support of this Notice and Application, AT&T Enterprises, Inc., shows the Commission as follows:

1.       AT&T Enterprises, Inc. (“AT&T Enterprises”), was a Delaware corporation, properly registered and authorized to do business in the state of Kansas as a foreign corporation.

2.       On April 30, 2024, the Commission issued its Order in Docket No. 24-SBAT-545-MER<sup>1</sup>, approving the transfer of AT&T Corp.’s Certificates of Convenience and Authority to AT&T Enterprises, Inc., to reflect a merger of the two entities effective May 1, 2024, with AT&T Enterprises, Inc., being the surviving entity.

3.       Further, on April 30, 2024, AT&T Enterprises, Inc., filed with the Commission its notice of adoption of AT&T Corp.’s Access Services and Network Interconnection Tariff in its entirety, effective May 1, 2024.<sup>2</sup>

4. Pursuant to its COC and Kansas law, AT&T Enterprises hereby formally notifies the Commission that on May 2, 2024, it converted to a Delaware limited liability company. As a result of the conversion, the company's name has changed to AT&T Enterprises, LLC. Attached hereto as "Attachment 1" and incorporated herein by this reference, is AT&T Enterprises, LLC's: (1) "Application for Registration Foreign Covered Business Entity" filed with the Kansas Secretary of State on June 4, 2024, and (2) Certificate of Good Standing issued to AT&T Enterprises, LLC, on June 6, 2024, by the Kansas Secretary of State.

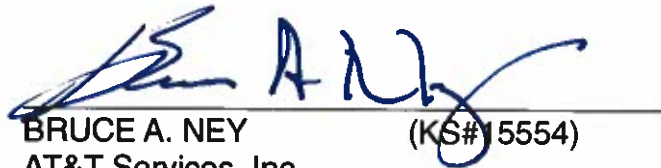
4. The change in corporate status and name will be entirely transparent to the company's customers and will have no impact on the day-to-day operations of the company, its customers, or the public generally. There will likewise be no customer or public confusion from this change; nor is any action required by a customer or member of the public because of the change. Further, the change in corporate status will in no way affect service rates, terms, or the conditions on which AT&T Enterprises now provides service in Kansas.

5. Because of the change in corporate status and name, AT&T Enterprises requests that it be allowed to submit new, fully amended or replacement tariffs reflecting the changes, within 45-days following the issuance of an Order approving the name change in this proceeding.

WHEREFORE, AT&T Enterprises respectfully requests an Order of the Commission approving this Application and reflecting AT&T Enterprises changed corporate structure and name in all company references, including on its COC and in all future Commission proceedings.

FURTHER, AT&T Enterprises respectfully requests that it be granted a 45-day period following the issuance of an Order approving the name change in this proceeding in which to file replacement tariffs reflecting the change in corporate status and name.

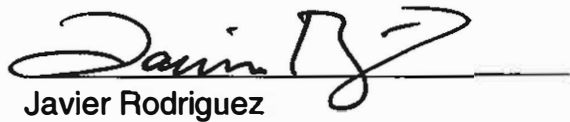

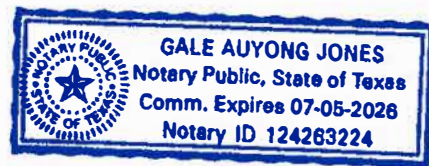

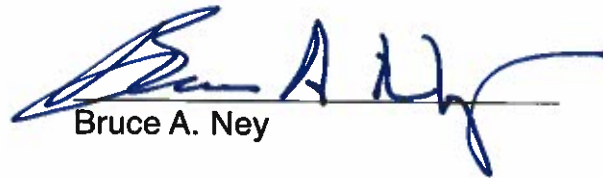
