**WITHDRAWAL OF MOTION TO SUSPEND INTRASTATE
MOTOR CARRIER OPERATIONS**

The Staff of the State Corporation Commission of the State of Kansas (Staff), by and through its counsel, files a withdrawal of its motion to suspend Gregory D Bribiesca d/b/a Hulk Towing of Holcomb, Kansas (Carrier) from intrastate commercial motor carrier operations. In support of its Withdrawal, Staff states as follows:

1. On May 7, 2024, the Commission issued Carrier a Penalty Order that assessed a civil penalty of \$300 for violations of the Kansas Motor Carrier Safety Statutes, Rules and Regulations discovered during a compliance review conducted by a Staff Special Investigator on April 24, 2024.
2. Carrier was sent a collection letter on June 13, 2024, reminding it of the amount due and giving it 10 days from the date of the collection letter to pay.
3. As of July 18, 2024, Commission records indicated that Carrier had not complied with the collection letter or the requirements of the Penalty Order.
4. On July 19 2024, Staff filed its Motion to Suspend Intrastate Motor Carrier Operations.
5. On July 19, 2024, the Carrier paid its outstanding civil penalty.

6. Carrier's actions obviate the need to be suspend the Carrier's intrastate motor carrier operations. Therefore Staff withdraws its motion.

WHEREFORE, for the reasons stated above, Staff respectfully withdraws its Motion to Suspend Intrastate Motor Carrier Operations.
