Attached for electronic filling are revisions to the Brightspeed Companies of Kansas Local Exchange Service Tariff. The following revisions to the Local Exchange Tariff are included in this filing:

This filing increases monthly rates for all business flat rate access lines and certain residential and business Key Trunks. These increases comply with HB 2131 changes to 66-2005(q)(1)(F) effective July 1, 2016, and are within the change permitted by the increase in the consumer price index for all urban consumers. In addition, the monthly rate for Metroplus will be decreased for residence and business services.

Included as Attachment A, please find the Consumer Price Index for all Urban Consumers in 2023 and 2024. Attachment B is information supporting the business access line rate changes proposed in this filing. The changes are guided by the change in the Consumer Price Index as noted in Attachment A. Attachment C includes a copy of the customer notification.

In compliance with existing rules, we make this filing on at least thirty days' advance notification and anticipate a February 5, 2025 effective date.

Following is the verbiage contained in Brightspeed's Customer Notice bill messages associated with the pending rate increase for residential and business customers.

#### Residence (All Exchanges)

Effective February 1, 2025, the monthly rate for Residential lines will increase by up to \$0.47. Key Trunks will increase by up to \$0.87. The Metro bundle will increase by up to \$0.47. The following bundles will increase by up to \$2.00: Economy Pack, Economy Pack Plus, Economy Pack Plus Lite, Simple Choice, Home Phone IIA, Home Phone IIB, Sure Solution II, Custom Solution I, Classic Solution, Clear Solution, Core Solution, Personal II Solution, Home II Solution, Special Plan – Metro, Simple Solution, Progressive Plan, Follow Me Plan and Essential Home Phone Plan. Simple Choice Unlimited A and Simple Choice Unlimited B will increase by up to \$4.00. Safe and Sound II Solution and Practical Solution will increase by \$0.47.

#### **Business (All Exchanges)**

Effective February 1, 2025, the monthly rate for Business lines will increase by up to \$0.79. Key Trunks will increase by up to \$0.90. PBX Trunks will increase by up to \$1.12. Remote Call Forwarding will increase by up to \$2.00. The following bundles will increase by up to \$5.00: Business Assist Advantage, Business Unlimited Business Unlimited Additional Line, Sure Solution II, Classic Solution, Preferred Solution, Priority Solution, Economy Solution, Economy II Solution, Economy IIA Solution, Complete Business, Complete Business Second through Ninth Lines, Multiline Month-to-Month, Multiline 1 Year, Multiline 2 Year, Multiline 3 Year, Connected II, Economy IIB Solution, Complete Business II, Basic Offer Month-to-Month, Basic Offer 1 Year, Basic Offer 2 Year and Basic Offer 3 Year. Rotary + Classics will increase by \$3.29. Sure Solution II Discounted and Economy I, II and IIA Discounted will increase by \$4.50.
