Customers may subscribe to an optional qualifying Brightspeed High-Speed Internet Access service at each package location. Brightspeed High-Speed Internet Access is governed by the terms and conditions listed in the <u>Brightspeed Internet Service Agreement</u>.

C. Terms and Conditions

- 1. Components of the Brightspeed Voice will be converted to ala carte rates for the remaining services if customers remove any of the qualifying services.
- 2. All terms and conditions specified elsewhere for the respective services/features requested as part of this plan shall apply.
- 3. Services selected as part of this plan can only be provided where technically available and compatible with other services the customer may choose to order.
- 4. Brightspeed Voice cannot be combined with any other discounts unless otherwise specified.
- 5. This plan is not available to customers who are or become toll restricted. Service Charges will not apply for those existing lines converted, in-place, to residence exchange service due to company-initiated toll restrictions. Such customers will not be permitted to re-enroll in this plan until such time as all associated unpaid balances are satisfactorily paid in full.
- 6. The Company retains the right, in its sole discretion, to change some or all of the network technology on which it delivers this service and the associated long distance service, including a change to Voice over Internet Protocol technology. If the Company's network technology changes in such a way that this Local Terms of Service will no longer apply to Brightspeed Voice, the following monthly rate will continue to apply, and the new service(s) or plan(s) will be governed by separate, commercial terms between the Company and the customer.

Customers may subscribe to an optional qualifying Brightspeed High-Speed Internet Access service at each package location. Brightspeed High-Speed Internet Access is governed by the terms and conditions listed in the <u>Brightspeed Internet Service Agreement</u>.

C. Terms and Conditions

- 1. Brightspeed Business Voice lines cannot terminate into a PBX except as otherwise indicated herein.
- Services selected as part of this plan can only be provided where technically available and compatible with other services the customer may choose to order. All terms and conditions specified elsewhere for the respective services/features requested as part of this plan shall apply.
- There is no minimum service period for the Local Exchange Service and features provided in Brightspeed Business Voice. Customers who discontinue this service within thirty days after establishment of service will be charged only for the number of days of service.
- 4. If Customer discontinues any of the required services or features, the remaining components of the Brightspeed Business Voice selected by the customer will be converted to a la carte rates. If optional High-Speed Internet service is discontinued at any package location, the discounted monthly rate will no longer apply and all Brightspeed Business Voice lines at that location will be converted to the applicable monthly rate.

If the qualifying service being discontinued is High Speed Internet, Brightspeed will charge Customer the Early Termination Fee, if applicable.
